



- (A) Right is reserved to make changes at any time, without notice, in prices, materials, specifications and equipment. Orders are accepted subject to prices prevailing at time of shipment. In order to show equipment size and location, line drawing may include some optional items.
- (B) Weight shown is estimate of model's maximum weight displacement with largest engines available, average optional equipment aboard at time of delivery and fuel and freshwater tanks filled. Capacities of tanks are estimated to be total capacity of all tanks normally furnished in this model. Usable capacities will vary depending upon conditions.
- These prices apply only if order is placed prior to boat going into production.

- (D) Includes swing-down ladder to water, aft deck gate and transom ladder.
- (E) One set of sheets includes: one bottom sheet, one top sheet and one pillowcase. Colors on request.
- (F) Prices are for surface-mount only. Custom installation extra.

THERE ARE NO EXPRESS WARRANTIES ON PRODUCTS MANUFACTURED BY HATTERAS YACHTS, EXCEPT THAT The Company will, through its selling Dealer, replace or repair, at the Company's option, any part (except as hereinafter provided) which is proven to its satisfaction to have been defective at the time of delivery to the first owner, and which defect is discovered within six months from the date of delivery to the first owner, if the part is returned, transportation prepaid, within thirty days after the defect is discovered, to the Dealer or to such other point of manufacture as the Company may designate.
- This warranty shall not apply to:
 (a) The cost of removal or reinstallment of part, or disassembly or reassembly of the unit of which it is a component.
 - Varnishes, gelcoats, paints, fabrics, chromium plated and stainless steel finishes because of the varying effect resulting from different climatic and use conditions. (c)
 - Products not of the Company's manufacture. Any warranty provided by the manufacturer will be passed on to the owner if possible.
 - The installation of any equipment by a Dealer or other installer.
 - Racing boats or engines.
 - (f) Speeds, fuel consumption and other performance characteristics because they are estimated and not guaranteed.
 - (g) Conditions resulting from misuse, abuse, negligence, alteration or lack of performance of
